

## **TERMS AND CONDITIONS OF PARTICIPATION**

The terms and conditions for this competition have been deposited with Athens-based notary public Olga Fotopoulou, 47 Solonos St., GR-10672, tel. 210 3617704, and Deed No 449/16.6.2015 has been drafted regarding the deposit of the Terms and Conditions of Participation in the Competition.

### **1) Scope of the Competition – Organisation**

The company with the corporate name AEGEAN AIRLINES S.A., with registered offices at 31 Viltanioti St., Kifissia, Attica, is organising “BLOGTROTTERS GR –WIN A TRIP FOR YOUR FANS” competition / promotion (here in after the “Organiser” and the “Competition”) which will start on Wednesday, 17 June 2015 at 08:00 hours (Greek local time) and will end on Friday, 19 June 2015 at 15:00 hours (Greek local time). The prize consists of six (6) airline tickets for three (3) lucky winners. The winners will be chosen by draw, and will win six (6) return tickets of the Organiser to fly to Greece.

The Competition web tools and its general monitoring shall be overseen by ISORBARIPROSPECT, with registered offices in Aristotelous 95 & Astroxoriou 1,(ISOBARIPROSPECT).

The Organiser hereby invites the Bloggers that they will participate to Blogtrotters event (hosted and organized by Marketing Greece) which will take place at Thessaloniki and Chalkidiki, to shoot photos or videos and upload them at their social media accounts using the #AegeanAirlines. By using the #AegeanAirlines will have the opportunity to participate to the draw which will showcase the three (3) winners.

The Organiser assumes no obligation to secure or facilitate access to Internet sites or to provide the relevant facilities to any interested party with respect to their participation in the Competition. Access to the Competition is only permitted under the operating terms and conditions for the relevant server and the technical and other conditions and specifications for the Competition. The Organiser hereby

considers that each participant is the subject of, and has exclusive control over, the personal data he/she provided. The Organiser shall not be liable for any amount charged to the participants/users due to the aforementioned grounds.

## **2) Eligibility**

Anyone over the age of 18 may participate in the promotion/competition.

Individuals falling into the following categories are excluded from the Competition:

- (a) anyone under the age of 18,
- (b) anyone who has not agreed to these terms and conditions of use,
- (d) the employees of the Organiser,
- (d) the employees of ISOBARIPROSPECT,

- (f) first- and second-degree relatives of the employees referred to in paragraphs (c), (d) and (e) above and the spouses of said employees.

The winner of the Competition may not designate a substitute to receive the prize nor request exchange of the prize for money or any other replaceable items.

- Any ticket not used for any reason will be cancelled and the winner may not claim any other prize or any compensation or remuneration.
- The Airline's liability is limited in accordance with the applicable Greek and International legislation.

**4) Date of start/end of competition/promotion – Duration** The Competition will start at 08:00 hours (Greek local time) on Wednesday, 17 June 2015 and will end at 15:00 hours (Greek local time) on Friday, 19 June 2015. The Competition computers (including any automated subsystems – count-down web tools made available to the Organiser by ATCOM) shall be the official timer of the Competition determining the Start Time, the End Time as well as the time of active sending of an entry or apparent receipt by the application of a Competition entry.

It is hereby expressly stated that, after the end date of the aforesaid Competition, as announced in the terms and conditions of use of the Organiser's page and as posted on Aegean's Competition page during the Competition closing procedure, no entry will be accepted by, or be binding upon, the Organiser in relation to whether the entry was submitted in good time or not.

#### **5) Change of Terms and conditions of use**

#### **6) EXPRESS DECLARATION – CONSENT – ACCEPTANCE BY THE PARTICIPANTS**

## **8) Withdrawal of Notice – Amendment of Terms - Liability**

The Organiser shall be entitled to withdraw the Competition notice, in whole or in part or to amend these terms (including the duration of the Competition and the dates of conduct of the draws), or to exchange the prize offered (tickets) with another of an equal value during or after the Competition. In this case the Organiser shall bear no liability whatsoever for any compensation with regard to the winners of that draw.

The Organiser shall bear no liability under any circumstances for any direct or indirect losses, expenses or costs which may arise from any interruption,

malfunction, delay or any other reason, concerning the Competition prizes. ## **12) Applicable Law – Jurisdiction**

These terms and all types of contractual and non-contractual relations arising as a result of their implementation shall be governed by Greek law for all participants. Any dispute related to the Competition that may arise in the future, falls under the exclusive jurisdiction of the Courts of Athens, even with respect to non-residents.
